MERGER OF THE MULTIPARTNER SICAV - ROBECOSAM SUSTAINABLE WATER FUND AND IMPACT ON YOUR RL360 PLAN - <PRODUCT> - <PLAN NUMBER>

Multipartner SICAV has announced that it will be merging its Multipartner SICAV - RobecoSAM Sustainable Water fund ("the merging fund") into a corresponding sub-fund from the Robeco Capital Growth fund range on Friday 30 October 2020. As you provide advice to one or more plans invested in the merging fund, we wanted to make you aware of the action we will be taking and explain your options for switching to a different fund if you prefer.

The plans advised by you and impacted by this notification are listed at the end of this letter. We have not written directly to the owners of the plans listed. As each plan owner has appointed your company in the capacity of investment adviser to manage the investment choices on their behalf, you should contact them as necessary to discuss the details of this notification and any recommended course of action.

Reason for the merger

Multipartner SICAV are planning to merge the merging fund into the Robeco Capital Growth Funds - RobecoSAM Sustainable Water Equity fund ("the receiving fund") to improve operational efficiency, provide better economies of scale and improve commercial attractiveness.

The investment objectives and policy of the receiving fund will remain the same as the investment objectives and policy of the merging fund. The ongoing charges ("OCF") of the receiving fund will be at a reduced rate to the merging fund.

A comparison of the merging fund and receiving fund can be found in the table overleaf.

What happens next?

We will close the merging fund to new business and switches in with effect from 19 Oct 2020 at 3pm (the "effective date"). As your clients are existing investors, they can continue to invest in the merging fund until the effective date. The receiving fund is due to become active on 30 October 2020. Due to the receiving fund being a new fund launch it could cause administrative delays so we will automatically switch your clients' holdings, and redirect any regular payment allocation, into the receiving fund on or before 4 November 2020.

After the effective date, dealing in the merging fund will be suspended. In the event that the suspension is required on another date and/or needs to be significantly extended due to unforeseen circumstances, shareholders will be informed accordingly.

Please note that although the switch value from the merging fund to the receiving fund will be the same, your clients will receive a different number of units in the receiving fund as the unit price is different to the merging fund. Once completed, details of the switch will be available to view via the transaction screen for each plan on our Online Service Centre. If you are not already registered to manage plans online, you can sign-up at www.rl360.com.

Your options

If you are happy to invest in the receiving fund, you don't need to do anything. However, if you would prefer to switch to a different fund available to your clients plans, it's free of charge and very easy to do.
