CHANGES TO THE VAM MANAGED FUNDS (LUX) – DRIEHAUS FUND AND IMPACT ON YOUR RL360 PLAN <PRODUCT> <PLAN NUMBER>

VAM Managed Funds (Lux) has announced a number of changes to its VAM Managed Funds (Lux) – Driehaus Fund (the “Fund”) that will take effect on 1 September 2021 (the “effective date”).

Your plan invests in the fund so we wanted to make you aware of the changes and explain your options for switching to a different fund if you prefer.

Summary of the changes

From the effective date the name of the Fund will change from VAM Managed Funds (Lux) – Driehaus Fund to VAM Managed Funds (Lux) – VAM Fund.

Also the investment manager of the Fund will change from Driehaus Capital Management LLC to Rivers Capital Management Limited.

Finally the investment policy and objective of the Fund will be amended in order to broaden the investment scope of the Fund. A comparison of these changes can be found overleaf.

Your options

If you are happy with these changes, you don't need to do anything. However, if you would prefer to switch to a different fund available to your plan, it's free of charge, and very easy to do. You may want to discuss the options with your financial adviser before deciding.
